MASTER OF ARTS – GEOGRAPHY – 2020-21 Plan I – Thesis & Plan II - Exam

In addition to departmental requirements, candidates for graduate degrees must fulfill University requirements described in the "Graduate Education" section of the UCSB General Catalog.

Time-To-Degree for the M.A. in Geography is 4 years.

The M.A. degree can be obtained through a Thesis Plan I, or an Examination Plan II.

Thesis Plan I: A total of **34.0 units** are required. At least **20.0 units** must be from 200 & 500 level
Geography units, exclusive of GEOG 201, 200ABC, 500, 597, 598, and 599. No more than half may be in GEOG 596. Examination Plan II: A total of **46.0** units are required. At least **24.0** units must be from 200 & 500 level Geography units, exclusive of GEOG 201, 200ABC, 500, 597, 598, and 599. No more than half may be in GEOG 596. The core courses must be passed with a grade of 'B' or better with the exception of GEOG 200A and GEOG 201, which must be passed satisfactorily. The M.A. through the Examination Plan II is a terminal degree (no continuation to the Ph.D.)

MASTER'S COMMITTEE

The Master's Committee consists of at least three UC Academic Senate members, with a tenure-track faculty member from the student's major (home) department serving as chair or co-chair. At least two members of every committee must be tenure-track faculty. The majority of the three members shall be from the student's UCSB major (home) department. The thesis requires the signatures of all members of the committee, as nominated on Master's Form I.

CAPSTONE REQUIREMENT				
Thesis Plan I: Students are expected to write and defend an original M.A. thesis. Required coursework must be completed by the end of the quarter in which the thesis is submitted. The student's Master's Committee supervises the thesis research and certifies the completion of required coursework.				
Examination Plan II: Students have to pass a Comprehensive Examination, conducted by the student's advisor and examination committee. The scope and structure of the exam shall be determined by the advisor, the committee, and the student. A student who fails to pass the examination, may try once more without penalty, taking the retest during the quarter following the failure or at the next available opportunity thereafter.
